This PCN affects the VCXO product built at the Vectron's U.S facilities in Hudson , N.H. and Mt. Holly Springs, Pa.

For several years, Vectron has been using qualified key off-shore partners for work-assist and to ease capacity constraints in the U.S. factories. With recent upsurge in demand Vectron has found it necessary to rely more on these partner factories to support the production of price-sensitive, low-end VCXO products, typically 7x5 ceramic-packaged parts.

While Vectron has notified and will notify major customers whenever a part is transferred to its partner factories, this PCN is intended to serve as a general notification to all customers¹ that Vectron will be supporting future deliveries using product built in the off-shore facilities. Product built by the partners is form, fit, function compatible with existing equivalent parts built in the U.S. factories². For traceability, product sourced in this manner can be identified with a special mark on the cover: a letter such as "K", "T1", "T2", "J" following the stamped date code.
